SUBJECT: Regional Centers for the January 2017 Regents Examination Period

Emergency supplies of examination booklets will be located at the centers listed below. These centers are intended to provide examination booklets for last-minute emergencies, when copies can no longer be obtained from the Department. The officials in charge are authorized to release examination booklets only on the day of the examination. Only materials for morning examinations will be released in the morning; materials for afternoon examinations may be released any time after 11:00 a.m. Scoring materials for the Regents Competency Tests (RCTs) in Mathematics, Science, Reading, Writing, Global Studies, and U.S. History and Government, and the Restricted Regents Examination in Physical Setting/Physics will not be released until after the Uniform Statewide Admission Deadline (10:00 a.m. for morning examinations; 2:00 p.m. for afternoon examinations). Scoring materials for all other examinations will be made available on the Department's web site at <http://www.p12.nysed.gov/assessment/scoring/> at approximately 11:00 a.m. for morning examinations and at approximately 3:00 p.m. for afternoon examinations on the scheduled administration date.

Please contact the official in charge of the center before sending a representative to pick up test materials. The person sent to pick up an emergency supply of test materials must present authorization written on school letterhead stationery and signed by the principal. The authorization must identify the person picking up the materials and list the specific materials requested. The school representative obtaining test materials must provide identification with a photograph, countersign the authorization letter, and leave it with the official in charge of the center.
