

## 2023-2024 Prekindergarten Variance from Collaboration Requirement

Education Law §3602-e and §3602-ee allow school districts to apply for a variance from the collaborative prekindergarten programming requirement. School districts must provide documented evidence to show that it is unable to establish a collaborative arrangement for approvable reasons outside the district's control. For a variance to be considered for approval by NYSED's Office of Early Learning, each section <u>must</u> be completed thoroughly.
