We purchase our Internet bandwidth from the Central New York Regional Information Center. They have guaranteed that they will provide the minimum required SSBA bandwidth of 100 MBPS per 1000 students; in our case that would be 552 MBPS (burstable). At present, they are not shaping our traffic and will not do so until they can provide 24/7 firm service.

Over the past 5 years, the district has prepared our infrastructure for the necessary upgrades that will ensure maximum benefit from all existing and future technologies. This includes:

- 1. Upgrading all wiring by replacing Cat 5 with CAT 5e or CAT 6 as part of capital projects.
- 2. Changes have been made to all major parts of our data infrastructure including the upgrading of storage servers, firewalls, content filters, etc.
- 3. Installation of WAP's in all buildings in the district. All classrooms and instructional spaces have both private and public wireless access 24/7. In order to maximize the effectiveness of existing and future technology, additional work must take place. Our network switches are 10 years old.

Parts are still available but the model of switches are no longer in production. This SSIP is dedicated entirely to replacing all network switches. Upgraded to 10 GBPS within buildings and 40 GBPS between buildings. The plan requires no new wiring only a one-for-one swap from the old switches to the new. New stacking cables are required to connect components but again, that is a one-for-one swap.

Our Smart School Investment Plan supports and links to our Technology Plan. First, and foremost all technology activities require the transmission of data packets over a network. Our spending plan is 100% dedicated to providing a robust infrastructure of network switches to move data quickly and efficiently. Without this capacity, no other aspects of our Technology Plan can occur. Our current infrastructure of switches is over 10 years old and is at "end of life". In order to move forward with the rest of our Technology Plan, we must insure that the network can handle the increasing demands. Referenced below are some technology activities that require a robust network backbone as detailed in our SSIP.

The Technology Committee posed the following essential question:

What implications do "cloud computing" and mobile technology have on learning and instruction?

We realize that with these implications, will come the need to upgrade the network backbone, wireless capacity and increase internet bandwidth.

Therefore, this SSIP is dedicated entirely to replacing all network switches. Upgraded to 10 GBPS within buildings and 40 GBPS between buildings.

Beginning in 2012, the BCSD began to provide wireless networks in District buildings during the last 2 capital projects. We used distribution and spacing recommended by the Electrical Architect of 75 foot spacing along all corridors. Last year we invested in an additional enterprise wireless controller and have replace the original WAP's in the High School (our highest traffic area) with one WAP in every-other classroom. For the remaining buildings, we conducted a wireless mapping survey to find any "dead spots". Those we identified, we placed a WAP in the location. All buildings have a bifurcated wireless network which consists of a "Public" and a "Private" network. All privately-owned wireless devices connect to the public network. The Public network is available for school-related purposes and does not require a log in. This network is limited to a fully-filtered connection to the public internet through BOCES. There is no access to District technology resources including the storage area network. District-owned wireless devices may connect to the Private network. This network requires a secure password and a login through the LightSpeed filter. Access to District technology resources is available through this wireless network. Access to this network must be approved by the Director of Technology.
