The district believes that this investment into the security of all buildings in the Canajoharie Central School district will help ensure the safety of our students, staff and guests.

The engineering/programming/management for this proposed investment was completed by SEI Architects. The installation and setup of the security equipment for the proposed investment will be done by Day Automation. Hardware proposed as part of the investment consists of a variety of manufacturers including: Avigilon, Bosch, Corbin Russwin and Day Automation.
