Greece Central Schools believes that all students are more successful in a safe and secure environment. There are many components to safe and secure schools. Greece Central wishes to improve on three of those.

The first is door security. Greece Central Schools has long had a door security system for their main entrances. This manages individuals that wish to visit the school. Individuals must be identified and approved before they enter any buildings. Greece Central Schools is proposing to use Smart School funds to expand this system to additional entrances at the schools. This will reduce uncontrolled entrances. This system can also be linked to the video security system in the buildings. When a staff member's identification card is used for access to a building, the video security system will record that person entering the building. In the event that a card is lost or stolen, the district will have a record of any unauthorized use.

The second component that Greece wishes to address is the video security system. Greece does have a system, but it is limited in camera quality and video storage capacity. Greece Central Schools wishes to expand and upgrade their system. The system will include a significant number of additional cameras to provide more coverage at more location in the buildings. Additionally, the district will install high resolution cameras on the exterior of their buildings. These cameras will record campus events that are in violation of school policies. Finally, the district wishes to install high volume video storage servers. The district has some storage on their existing system but it is limited. The new servers will allow the district to store 30 days worth of video for all cameras. They will also be able to archive video records of specific events or incidents as required.

The third component of Greece Central School's plan for improved safety and security relates to windows. Greece has identified the windows at many of the entrances as a vulnerable point in their district security. In many buildings there are a number of glass vestibules and large windows. These areas offer students great views and an abundance of natural light. They also are a vulnerable location to vandalism and intruders. Greece Central School is proposing the installation of secure window film on the outside of these windows. This film prevents breakage or shattering. In the event someone throws a rock at the window, the glass may crack, but it remains intact and prevents access to the building.
