High-Tech Security Features

 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Roscoe Central Schools is a small, rural school district in the Catskills. Security for their students is still the number 1 priority. This plan proposes to use Smart School funds to strengthen components of that system.

The first area of the project is door security. Roscoe proposes installing door "swipes" at all of the primary entrances. No longer will the district provide keys to the entries that are easily misplaced. All staff will have a photo identification badge with a magnetic strip that can be used at the primary entrances. The staff member will swipe their card and the door will automatically unlock. The staff member can enter. Additionally, fire doors will have a contact installed that notifies the administration when those doors are opened. This will prevent someone from blocking the door open allowing unauthorized access to the building. The system can be programed to allow coaches and extracurricular staff access on weekends and evenings and limiting some staff members to access from 7 to 4 on school days and not outside of the school day..

The districtis also proposing the installation of additional video cameras on campus as a component of this plan. While the district has a working video system, the areas covered are limited leaving a number of areas without monitoring. This plan calls for additional cameras both inside and outside the building. Additionally, the district would like to install a new video server for the camera system. The larger server will allow the district to store a larger volume of video records and also allow them to archive the video of events for future reference.
