Note: This amendment corrects the project numbers listed in **Question 2** of this section and corrects the response for Streamlined Review in **Question 3.** All other information is unchanged from the originally approved project. There are NO changes to the expenditures or category budgets. This amendment is created based on a correction from the Office of Facilities Planning (Sigrid Coon). The originally approved project listed an incorrect <u>Project Number in Question 2</u> which has now been removed. To prepare for this SSBA project, the District worked with an outside security consultant to evaluate the key security needs of the district. The safety security survey results identified the following needs:

- Additional camera coverage needed in all buildings especially in these areas:
- · Exterior areas and parking lots of all buildings

• Stairwells

- 2nd and 3rd floor of the high school
- All corridors at the middle school
- · Playgrounds and athletic fields
- Need access control monitoring for all doors
- · Need a way to notify visitors if a building is in lockdown
- Need a way to notify staff and students that are outside when a lockdown has been called

Orchard Park CSD currently has 142 security cameras across six instructional buildings. A BOCES project during the 2018-29 school year provided funding to upgrade the security camera file servers to provide capacity for future expansion and to allow for longer retention times for captured footage. District administrators, the School Resource Officer, and the outside security consultants walked the inside and outside areas of each building to identify key areas that do not currently have adequate coverage by a security camera. This information was compiled into a comprehensive plan that is the basis for this Smart School Bond Act funding request under the High Tech Security category. OPCSD will purchase fixed-position security cameras to increase camera coverage in potential problem areas including hallways, stairwells, and entranceways. Exterior cameras will be purchased to improve visibility around the buildings with a special emphasis on coverage for entrances, bus loops, athletic fields, playgrounds and parking lots. Several of the current cameras will be replaced with newer cameras that have higher resolution, and other advanced features. Many of these cameras will have dual or quad sensors that will allow for a 360° overview or a combination of overviews and close-up views. Where possible, current cameras will be re-deployed to less critical areas of the campus. The District also will also be expanding its VoIP communication solution that supports lockdown notification through speakers and visual alerts for high ambient noise areas and large spaces. This project will add speakers to all hallways at the Middle School and the High School. VoIP speakers were added to hallways at the elementary buildings last summer as part of a BOCES project. This project will ensure that there is adequate coverage in all areas in the event of a lockdown code or other types of emergency notifications. In order to provide communication outside of the building, this project will include the installation of horn speakers placed around the perimeter of the buildings to notify people outside of the building of a lockdown. Strobe lights will be installed along with signage at all entrances that have card access so that people outside of the building are aware that the building is in lockdown and they cannot enter. The final part of the High Tech Security project will be the installation of hardware on all doors that will allow office and security staff to monitor door access 24 x 7. This will eliminate the problem of doors being propped open and then left unattended for long periods of time. The District's proposed spending plan includes those items along with architectural and engineering support, installation labor and incidental costs.
