We would like to repurpose the funds planned for a Cat 6 upgrade to purchase additional interactive displays (Classroom Technology) so that every classroom will have these installed. The boards have greatly benefited our students and staff in their instruction.

Using the Smart Schools Bond Act funds, we plan to replace all Smart Boards and projectors in Jr/Sr High School, Intermediate School, and Primary School with Interactive Flat Panel Displays-1 per classroom compatible with Apple OS, Windows OS, and Chrome OS.

The district has ensured that adequate electrical supply is in place to support the increase in devices, through consults with our building maintenance teams, engineers, and architects.

Since going 1:1 with chromebooks going home with students, we have found that we no longer need chromebook charging carts, but do need additional mobile devices, specifically student use chromebooks.

There were funds remaining in other costs as those were previously allocated to charging carts for chromebooks. After deployment, it was identified that we did not require the number of carts that were planned for in the project. Additionally, the funds for Laptop computer were a result of cost savings and our puchasing a smaller quanity of the devices that originally planned for.
