At present, some classrooms have obsolete or broken projection type Smartboards that need to be replaced, and other classrooms do not have any form of this technology. Some funding will also be used to purchase new iPads for classroom instructional use. This equipment is compatible with our existing broadband wired and wifi internet service, and with the desktop computers in each

Describe how the proposed technology purchases will improve teaching and learning inside or outside of the

This technology engages all types of students and facilitates differentiated instruction. An interactive display panel helps students with autism and other developmental disabilities improve communication and social interaction skills through group collaboration and increases students' time on task ability. The interactive display panel gives educators the ability to present things visually in a large format and provides ease in creating and modifying activities to enhance students' learning in all academic subjects at all levels. Some students have fine and gross motor delays and having the ability to learn/practice academic skills in a large format, using the touchscreen, enables students to better access the instruction. The interactive display panel also provides student with opportunities for virtual field trips in the local community and beyond. For many of our students, trips outside of the school building can be challenging. Helping our students learn about their community and other cultures around the world becomes possible through this technology. lpads allow teachers to develop student-specific applied behavior analysis programs, collect data on that instruction and chart progress towards IEP goals directly with the student on the iPad. Additionally, many of our students are non-verbal or have limited verbal language and iPad apps allow our students to communicate with greater ease and also facilitates the students' use of verbal language. Increased opportunity for appropriate communication also decreases frequency of challenging behavior in students with autism.
