 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

We plan to use the SSBA funds to replace and upgrade our current security camera servers in the High School and Elementary School buildings along with upgrading our lockdown button system. The new servers will have the required Microsoft Server 2023 software, Avigilon software, and capacity for at least 1 month of video storage. The servers are designed with an appropriate capacity for future expansion of either upgraded cameras with higher pixel resolution and/or additional cameras.

Day Automation will furnish and install (2) replacement 160TB video recording servers for Candor Central School District. Premium servers provide 10G networking and analytics.

- Installation of Part # NVR5-PRM-160TB-EDU- NVR5, Education Series Premium 160 TB RAID6 in the HS and Elementary School Buildings
- Installation of Microsoft Server 2022 on each server.
- Current licenses of Avigilon software will be added to the server (Software is not purchased in this proposal). Our current Avigilon Control Center (ACC) software will be added to the NVR servers. This software does not currently, nor will it in the future, collect or store any biometric data or use any facial recognition technology.

We will also be upgrading our current lockdown appliances in each building to meet New York State's security recommendations that will allow the system to automatically call 911 when a lockdown is initiated. The system improvements to our lockdown equipment are centered around Day Automation's Incident Response Panel (IRP). The IRP is a centrally located hub per building that tightly integrates the access control system and the monitoring system, while providing a standardized connection point to an audio system (not part of this proposal). With this upgrade, our system will have a more robust hardware lockdown button, more robust door security, and more robust notification to local police.

The IRP is designed to notify Rapid Responses' UL listed monitoring facility with the first goal of notifying local police of a building Lockdown and what building it was initiated from.

- The IRP provides a constantly monitored heartbeat to Rapid Responses' monitoring facility to ensure 24/7 emergency capability.
- The IRP takes an input directly from a physically hardwired Lockdown Button.
- o Because the lockdown buttons are hardwired, they are supervised and will provide an audio warning if any wiring issue occurs. Lockdown Panel and button upgrade and installation will include:
- Furnish and install (2) momentary lockdown buttons
- Rewire (2) existing momentary lockdown buttons
- Furnish and install the necessary equipment and interconnections between the IRP and the districts' access control system.
- Includes testing of the newly configured system to ensure the Rapid Response Monitoring Facility receives the Lockdown signal.
- Includes customer training on system activation and system reset.
