 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Although our security project is basically the same project, this amendment is being filed to account for changes in two areas. The design of the servers that will be used to store our footage has changed due to a redesign of our computer network. At the time this project was proposed and submitted our network was designed as a hub and spoke with data traveling from building to building via a Fiber WAN. Over this past summer we redesigned our network to eliminate the Fiber WAN and have each location with its own dedicated internet connection. This change will now require each of our school's to have their own server for camera footage storage which accounts for the removal of the large camera servers and the addition of smaller servers to each school. Also, we have incorporated a new camera design that will save us on cabling. The cameras on the original plan required a single cable run per camera. The majority of the single cable run cameras have been removed and replaced with cameras that have multiple heads to record in different directions and will only require a single cable run. Lastly, we have included the addition of exterior cameras that have aged out and are ready to be replaced.

All plans and specifications for the erection, repair, enlargement or remodeling of school buildings in any public school district in the State must be reviewed and approved by the Commissioner. Smart Schools plans with any expenditures in the High-Tech Security category require a project number from the Office of Facilities Planning.
