Both the interactive panels and Chromebooks will be purchased so that compatibility between devices and platforms will be optimal. The District currently owns several Chromebooks, and the District has already tested functionality, usability and stability.

The technology purchased will continue to support all students as the District continues to upgrade learning spaces to interactive boards and 1:1 Chromebooks, resulting in student-led learning with increased student engagement. Goal one of the Instructional Technology Plan includes implementation of the New York State Computer Science and Digital Fluency Standards. Goal two speaks of introducing K-6 instructional staff to the writing process and the technology that will support the further K-12 initiative. This includes researching a K-12 writing process that will be utilized by instructional staff that will meet the needs of all learners, research and implementation of instructional technology tools that will support the writing process, and provide differentiated learning strategies for regular and special education students. In order to meet both of these goals, staff have been participating in professional learning, led by Instructional Technology Coaches, geared towards specific technology software tools. This professional learning will continue with the additional purchases of interactive whiteboards and student Chromebooks. Furthermore, Massena CSD continues to facilitate a Summer Technology Camp in which instructional staff learn strategies to meet specific learning outcomes. This includes differentiated learning strategies for Special Education students, ELL students, as well as students receiving tiered Academic Intervention Services. Specifically, the District continues to implement a K-12 ELA and Math benchmark software, iReady. iReady is an online software package that targets students instructional gaps, provides supplemental and curricular materials to assist teachers. The District uses the iReady goals in the AIS/RTI process which is a tiered intervention service in grades K through 9. The Chromebooks being purchased continue to support this District initiative as we work towards closing the learning gaps identified by the benchmark data.

It is the hope to see classes use tools like Google Hangouts and Communities to establish connections with other partners and countries beyond our walls. The SSIP submittal four will greatly increase the capacity and facilitate utilization of blended learning and differentiation through flipped classrooms, shared classrooms and online classrooms.

Professional development has always been a critical component to our success with implementing technology at Massena CSD. The district supports teachers in attending an annual summer technology camp. MCSD also provides a district instructional technology coach, (ITC) who is able to meet with all staff on a 1 to 1, small group, large group basis, as well as provide PD and assist with curriculum integration for all staff. The District continues to provide professional development opportunities in which to provide continuing education and best practices for all staff at MCS on staff days throughout the school year. This includes asynchronous learning opportunities where staff is able to explore technology tools within their Professional Learning Communities (PLCs) as well as in-person learning opportunities led by Instructional Technology Coaches and/or Building Administrators. Staff are also given the opportunity to share Tech Tools at Staff Meetings to further enhance instruction and student learning.
