 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

In the event of an emergency event at Lisbon Central School, getting the correct information to the students and staff is of paramount importance. Currently that is a challenge for Lisbon Central. Their current system is a traditional analog system based on a single amplifier and a spaghetti tangle of speakers daisy chained to each other. The signal produced by the amplifier is split smaller and smaller as it travels down the low voltage wiring until it becomes almost indiscernible in the classroom.

Lisbon Central is proposing a new Emergency Notification System based on the IP computer network already existing in every office, every public space and every classroom. Instead of a single amplifier sending out a distributed signal, the new system will have an IP based device in every room. These devices will receive a digital system through the network and generate a crisp clear message for the students and staff. Additionally, each device will include an LED display. On a normal day it will display the time of day accurately in each classroom. In the event of an emergency, preloaded messages could be displayed in the classroom. "Intruder in the building. Please lock your doors." Or perhaps, "Lisbon Central School will close at 2 PM due to inclement weather." The same message will be displayed in every space at the same time with the correct instructions.

The labor estimates in this application were prepared using the contract rates from the NY State Office of General Services and the prevailing rates in St. Lawrence County per NY State Municipal Law.

All plans and specifications for the erection, repair, enlargement or remodeling of school buildings in any public school district in the State must be reviewed and approved by the Commissioner.
