 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Brasher Falls has made a priority of school safety and security with almost all of their Smart School applications and funds. In the Entry Upgrade application, the district has a goal of securing the critical entrances to their buildings by upgrading the door frames, the doors, the latches, and in a separate application the actual windows them selves. At the completion of other components of this plan there were funds remaining in the Construction Contingency. The district wants to add these window sensors instead.

In this amendment they have identified that an additional number of windows both in the doors and elsewhere on the first floor are vulnerable even with the glazing on them. Brasher Falls is proposing to install window breakage sensors on these vulnerable locations. These units are physically attached to the window opening. In the event that there is an attempt to break the glass, the sensor will identify the location and the breakage and transmit that via the district wireless computer network notifying administration and facilities management. Emergency responders can also be notified.

IF a person tries to break into any of the buildings via the plate glass windows, critical staff and law enforcement are notified in real time instead of discovering the problem the next day or on Monday when the students and staff return, and it is too late to intervene.

Installation on this project is NYS OGS Regional Prevailing Wage rate in compliance with NYS bidding law.
