Baldwinsville Central Schools have been working to improve the security of the buildings in the district. They believe that students who feel secure in their environment will be able to focus better and achieve more. The district has been approaching this from a number of different directions. In other applications they have applied for or received funds to upgrade their door and window security, emergency classroom notification, and video security. This application is attempting to monitor what the students or parents who enter the buildings actually bring through the door.

Safety and security for all students all the time helps students to be more successful.

Baldwinsville is proposing to purchase Concealed Weapons Detectors. These units use advance digital sensors and software to monitor the students as they pass through the screening at a normal, walking pace. The units use the digital sensors to notify the system operators to the potential of weapons while ignoring false positives caused by cell phones, keys, and coins.
