Jamesville Dewitt originally applied for funds to upgrade their infrastructure using Smart School funds. The upgrades included upgrading Cat 6A on the "last link" including the WiFi connections. The district also proposed upgrading their fiber backbone to support 10 gig connection speed and finally to upgrade the physical structure of the Main District Wiring closet and their Intermediate District Wiring closets.

The initial estimate for the Cat 6 cable upgrades was inadequate for the actual work to be completed. The district had additional funds that could be used to complete the Fiber work and the physical Closet upgrades. This application proposes to RE-allocate the funds designated for the NON-Cat 6 work to the Cat 6 work that is required.
