Prior to the first approved SSIP, the District used e-rate funding to replace all network switches and install wireless access points in all instructional spaces. In addition, the District used local funding in support of a BOCES project to update several servers. The fiber backbone to Erie One BOCES gives the district a 1 Gb pipe to all switches.

The District already has a small number of iPads in all K-2 classrooms and this project seeks to expand that number to achieve a 1:1 program. Scaling up from the small number has allowed the technicians to implement systems necessary to support the larger number such as filtering, mobile device management system to remotely push apps and more. The iPads will be charged with intelligent charging carts in each classroom and the infrastructure is completely capable of handling the additional iPads. Apply stylus pens are used in digital art classrooms for precision use in the digital arts.

The additional iPad devices complete the needs for the District to be a full 1:1 K-12 district. This means all children in all classrooms will have a unique or individual device to use for all purposes during the school day. At the elementary level, for general class use, teachers will be able to demonstrate how to use the iPads for learning while each child has a device to use. This represents a shift because prior to this, while each K-2 classroom had six iPads, this meant that technology was limited as a center only for instruction. Moving forward, teachers will be able to instruct the whole class and give time for either individual or small group work with iPads. In addition, elementary teachers have identified a number of useful apps which we have successfully remotely loaded on the iPads. When the new iPads are delivered, we will be able to rapidly deploy the resources with learning tools pre-loaded for immediate use. Over time, teachers may request additional apps which can be added remotely and quickly, enhancing the teaching and learning process for all. The same devices are useful for many children with special needs, including teletherapy in some situations. As such, the new devices give the district the tools to support all children with special needs. In addition, the District has a small number of English Language Learners who receive support from an ENL teacher. The ENL teacher will be able to use the devices with apps specifically designed to improve English language acquisition.

The devices will help the District take a step forward in communicating with parents and other stakeholders. For instance, the District has deployed Google G-suite and some teachers and therapists use Google Meet to host video conferencing with therapists, parents, teachers and occasionally students where appropriate. At the high school level, college professors are invited into Google Classrooms in dual credit college articulation classes and we have the tools to virtually communicate with the colleges using G-suite Google Meet.

These tools have been tested and work well with our system. From a district standpoint, we offer professional development on all aspects of the G-suite including communicating with stakeholders. In addition to the virtual meetings, the District uses a student and parent portal for all secondary students. Students and parents are able to use their devices to see attendance, grades, report cards, transcripts and much more on an as-needed basis by accessing the portals with secure credentials.

The district has embarked on a Technology Camp Summer Institute program where we invite stakeholders to update their technology skills. Prior to the summer camp, we survey our staff to determine what needs exist and then seek to support staff with related professional development. In year one, over fifty staff attended the ten hour event. The District utilized a combination of BOCES trainers and District staff for training. In addition to the summer camps, staff have ongoing access to technology professional development in many other ways including local BOCES workshops, working with instructional coaches and more. Finally, administrators have modeled effective use of technology and set expectation for their staff to use and become proficient with a variety of technology skills within their buildings. All together, staff are constantly updating and refining their technology skills.
