High-Tech Security Features

Albion Central School has applied for funds for a High Tech Security upgrade. The district wishes to replace the existing analog emergency notification system. This antiquated public address system that they depend on during an emergency event is over 15 years old. While that wouldn't normally be a crisis, the company has discontinued this product and no longer provides replacement parts. The estimates for installation of the 487 classroom and public area devices approved in the original application were much to low to complete the work. The district has filed this amendment to increase the available funds for installation.

This includes **27** Advanced Network Devices: IP Clock with Flashers (Large), 2-way Audio, PoE/SIP, 28in long overall, **303** Advanced Network Devices: IP Clock with Flashers (Small), 2-way Audio, PoE/SIP, 18in long overall, Matte Black Finish, **37** Advanced Network Devices: IP Extra Large Signboard with Flashers, 2-way Audio, PoE/SIP, 51.92in long overall, SS construction, Includes Enclosure, **20** Advanced Network Devices: IP Speaker Audio Only (Surface Mount), 2-way Audio, PoE/SIP, Includes Enclosure, **71** Advanced Network Devices: IP Outdoor Speaker (Surface Mount), 1- Way Audio, PoE/SIP, Includes IP54 Rated Enclosure, and **29** Advanced Network Devices: Zone Controller, IP Endpoint with Analog Audio Out, Local Mic Input, GPIO Trigger Capabilities, PoE/SIP. The architect has revised the estimate and is requesting this increase to cover the costs of installation. ALL LABOR AND INSTALLATION has been updated per NYS OGS contract regulations and Municipal law "Prevailing Wage legislation." The numbers are significant but they are the legally required estimated rates.
