As other funds became available for most of the tablets and the interactive displays the district has requested that most of the funds committed through Smart Schools for those items be reassigned to High Tech Security.

Mount Markham Central School District believes that the most important service they can provide their students is a safe and secure learning environment to learn in. In a previous application, Mt. Markham had proposed to upgrade the building entrance security. This work was completed using other funds.

In this amendment the district proposes installing automatic door security on classroom doors. Currently the district has traditional door locks on classroom doors. While these seemed adequate fifty years ago, they create a vulnerability in the event of an unauthorized individual, or potentially a shooter who is in the buildings. The existing classroom doors require the teacher to stand in the hall with their key to lock the door. The new system will close and secure the classroom doors electronically when a panic button is punched. The teacher can focus on the students and not worry about standing in the hall locking the door while the "intruder" is traveling down the hall.
