Within the District, we currently have our own dark fiber between buildings supporting 10GB connections, and 10GB connecting to the wiring closets.

Orchard Park CSD currently has a robust Wi-Fi network in place containing 1 Aruba 310 Series access point per classroom/instructional area and multiple access points in larger common areas that support multiple channel connections to create a wireless meshed network. In an upcoming project, Orchard Park CSD is planning to upgrade the wireless network to Aruba AP-635 access points enabling Wi-Fi 6E. Below is a summary of the Aruba 310 Series access points currently in use.

With a maximum concurrent data rate of 1,733 Mbps in the 5 GHz band and 400 Mbps in the 2.4 GHz band (for an aggregate peak data rate of 2.1 Gbps), the 310 Series Access Points can quickly add required capacities to your existing or new wireless networks. The high performance and high density 802.11ac 310 Series supports 160 MHz channel bandwidth (VHT160), multi-user MIMO (MU-MIMO) and 4 spatial streams (4SS). It provides simultaneous data transmission to multiple devices, maximizing data throughput and improving network efficiency.

The 310 Series also has an integrated Bluetooth Aruba Beacon that simplifies the remote management of a network of large-scale battery-powered Aruba beacons while also providing advanced location and indoor way finding, and proximity-based push notification capabilities.

After a two-year pilot of various models of interactive front panels, Orchard Park CSD Technology Committee has selected ViewSonic as the interactive front panel to install in all classrooms and instructional spaces. ViewSonic interactive front panels provide an enhanced user experience with advanced technology and features.

One key advantage is the superior display quality of ViewSonic panels. They offer high-resolution screens with vibrant colors and sharp imagery, ensuring that students can clearly see and engage with the content being presented. This improved visual experience can significantly enhance learning and comprehension.

The professional development support for the integration of ViewSonic panels aligns with the multi-tiered system of professional development outlined in our District Technology Planning. This includes an initial comprehensive training for all new users, as well as embedded support through instructional technology coaches and training through online, self-paced training videos.

The District has 3 full-time dedicated instructional technology coaches (TOSAs),12 full-time technology department staff members and 6 building level technology instructional leaders. All of these individuals have been trained by ViewSonic's professional training team to provide a turn key "train the trainer" model of professional development.

To support the instructional use of ViewSonic boards, the technology coaches have created several professional learning courses available to Orchard Park teachers through our internal digital badging program. Since many teachers have used Smart Notebook to create lessons for our former Smart Boards, there has been been consideration and support for transitioning these lessons to ViewSonic panels. One benefit that was important in selecting ViewSonic as the panel to purchase is that ViewSonic panels are designed to seamlessly integrate with a variety of educational software and platforms, providing educators with a wide range of teaching tools and resources. This compatibility ensures that teachers can utilize their existing teaching materials and incorporate interactive elements effortlessly.
