 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Otselic Valley Central School District is located in a remote part of rural Upstate New York. Response time by law enforcement is not as rapid as the residents might desire.

The Otselic Valley Central School was built at a time when student security was a minor concern. Windows and doors were to facilitate access to the building. That period has ended. The students attending school need to feel safe and as secure as possible. Currently one of the vulnerabilities are the windows in the main entrance and the first floor classrooms. These windows were installed many, many years ago. These windows are traditional window glass and offer no deterent to someone attempting to enter the school. Additionally, the main entrance has large quantities of glass. The natural light is admirable. The potential for an intruder to use those windows for a non authorized entrance to the building is a distinct vulnerabilities.

Otselic Valley is proposing to resolve this issue with two components. The first is using a bullet and fracture resistent synthetic coating on the windows and doors at the main entrance. Nothing is bullet "proof", but an intruder would be unable to fracture the glass and gain entrance to the main entrance. Many people watched the events of January 6th 2021 on television. They noticed that the intruders at the U.S. Capitol building pounded on the windows again and again before the eventually gave way. These windows that had been in place for decades held up because of the synthetic film installed on the inside.

The second component is the actual classroom windows on the ground floor. Today, a non-authorized visitor could walk up to one of these windows and in a moment break the traditional glass and gain access to any classroom on the ground floor. The solution is replacement. These windows and frames can be replaced by actual "shooter attack glass." This glass would resist bullets or other projectiles long enough for law enforcement to arrive.
