Ravena-Coeymans-Selkirk has made a priority of planning and implementing security for their schools. Video Security has been upgraded using a previous Smart School project.

Door Security is the next item on their priority list. The current door lock system is a traditional system that depends on physical keys.

This provides a traditional level of security. At the end of the day, the doors are locked and no one can enter the room until the next day except the custodians. In a situation where there is an intruder in the building the system requires a teacher to stand in the hall and lock the door before a room is secure.

The district is proposing a new system of wireless door locks. Each door is part of a managed system. Each of the doors has a swipe card reader. An individual approaches and swipes their identification card and if they are authorized they can enter the space. Rooms can be set up for multiple users or limited to a single individual. In the event a staff member loses their identification card it can be disabled immediately from a central management console. More importantly, in a crisis, all of the doors can be automatically locked down preventing an intruder from entering a classroom, a group of classrooms, the classrooms in a single building, or district wide.

Additionally, because the system depends on cards and swipes, there is no unauthorized use of rooms. Physical keys are no longer required or a point of vulnerability.

All pricing for hardware is based on NYSOGS contract pricing. All labor rates are based on NYSOGS prevailing wage rates.
