1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Catskill Central has made a priority of providing a safe and secure learning environment to all of the students who attend. There are many components to a emergency preparedness plan and the district hopes to upgrade two components of that plan.

The first component of the plan is the upgrade to the district emergency classroom notification. Currently the district depends on an antiquated analog system. With that system there is a single amplifier powering speakers connected in a chain. Unfortunately the system divides the signal again and again and again until some of the rooms can't hear the announcements. In an emergency such as a lock down, the building administrations only know that a room or group of rooms didn't receive the announcement when the students begin exiting those classroom that didn't receive the emergency announcement.

The proposed system is attached to the district's computer network. The district technology team can identify a failed device before it is needed. The system can be programmed to reach a single room, a group of rooms, or the entire building depending on the emergency. Each of those devices contains a five watt amplifier and an individual speaker. So the sound is generated in each classroom. The same message is delivered loud and clear to everyone that needs to hear it. Administrators who are authorized can access the system via their cell phone no matter where they are in the building. No longer do they need to contact the Main Office to request an announcement. Finally, each of the classroom devices includes a large digital display. During a normal day the display serves as a digital clock. In an emergency that display can scroll preloaded messages. "Due to inclement weather, Catskill Central will close at 2 PM Today." Or perhaps "shelter in place, do not leave your classrooms." A total emergency communication system.

A second vulnerability that was critical during the Columbine incident was an unauthorized intruder. The district wishes to expand their intrusion detection system. Attached to the entry control system this series of monitoring devices will identify when individuals visit the buildings either when unauthorized or after hours. Combined with the video system and the door control system, when an unauthorized individual is detected the video security system will record who is intruding and the entry system will determine where the intrusion first occurred. The district will know immediately that there is an unauthorized visitor rather than depending on an eye witness to the visitor.
