Ellenville Central School has established a strong One-to-One learning environment. They believe that students who participate are much more successful than passive receivers of information.

Ellenville has evaluated their network infrastructure and while they are currently meeting the needs of their students, the district anticipates increasing demands on their network. The district is proposing to combine Federal E-rate Category 2 with Smart School funds to replace a wireless network that has been created over several phases. The new wifi network will eliminate inconsistencies in service delivery and cover some large group areas that have not been adequately served. Additionally, the new network will provide 10 gigabit network throughput to allow for growth over the next several years.

The Ellenville Central School has identified the establishment and continued support of a one-to-one learning environment. Students in a one-to-one learning environment are participatory learners instead of passive recipients of knowledge. The district believes that students retain more and can more successfully apply the information they learn in a participatory learning environment.

As the district has continued to develop this environment the demands on their IT network has continued to expand. This application is an effort to continue to support the growth of that network.

Ellenville regularly reviews their network and the ability to provide students with adequate services.

The district employs a full time network manager. He meets on an ongoing basis with administrative staff, to review the learning spaces in the district and the network demands in those spaces. The network manager then consults with the district architect, the network planning specialists from the Regional Information Center, and network specialists from equipment manufacturers to establish the best design and equipment for the district network.

Ellenville Central School has an Emergency Response plan that has multiple components. The district believes that the safety of the students is their number one priority. This application address two of those components.

The first component that the district wishes to address is the video security for their buildings. The district has an existing video security system. Unfortunately, it is an older system with analog components. The cameras have very low resolution and the system recorder has limited storage capacity and no extended retention capacity. The system upgrade includes additional high resolution digital cameras covering areas of the campus that aren't currently covered. This includes the bus turn around and parking areas. Additionally the system includes new digital video servers that can store recordings for up to 30 days and can archive specific events.

The second component is upgrades to the door security. Ellenville has door security on the main entrances. This requires a visitor to enter a double door alcove, identify who they are and where they are visiting. When the district has made sure this is supposed to happen, they allow the individual to access the rest of the building. This solves the issues with the main entrances. The challenge is the other 30 exterior doors in the buildings. These doors have no controls and opened without monitoring and even blocked open for a return visit. Who is in the building and why they are there is better with the Entry upgrade.
