Integral to this planning is access for SWD to the general education curriculum. We offer annual instructional technology training to new staff. We regularly host after school Appy Hours on basics in technology equipment and most often on leveraging the rich array of technology equipment to enhance teaching, and student engagement with learning in meaningful ways.
