When many of the current school buildings were constructed they were designed to be a center for the community welcoming one and all. Over the years that has unfortunately changed. While the buildings continue to be community centers, more caution must be exercised with who actually enters through any of the doors.

Brasher Falls has a building where several of the exterior entry doors and inumerous nternal doors needs to be upgraded. These doors were installed many many years ago. They cover entry from the play ground, the main entrances, and between classrooms and halls inside the building. These doors are no longer secure and don't offer any scope of protection for the students and staff behind them. As some of the students have commented, these doors just require a good PoP and they open. Some of these doors need to be replaced. Some of them need to have their casements upgraded. And some of these doors just need replacement of existing door swipes and controllers.
