1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

There are many many components to a plan providing a safe learning environment to students. Brasher Falls wants to address several of these using Smart Schools Funds.

One of the components is video security. Brasher Falls has previously taken steps to provide video security. This plans looks to expand that component. During the last couple of years, the district has identified several areas both inside and outside the building where video security should be improved. Either the existing cameras are of low resolution or there is no coverage at all. This plan attempts to remedy those situations.

A second component is the door locks for individual classrooms. Traditionally, classrooms were locked at the end of the day, and then unlocked when the teacher arrived in the morning with the classroom key. At that time, the biggest concern might have been an unauthorized visitor after school ended and the building was empty. Today there is an additional concern. Unauthorized vistors during the day when the classroom has students present. In the past, the key in the outside of the door was all that was required to lock the door. With an intruder, the opportunity to stand in the hall and lock the door might not exist. Brasher Falls is proposing to replace the door lock cores with units that can be locked from the inside of the classroom providing a safe and secure space for students to learn. The third component addressed by this plan is the actual windows in the building. Even if the door is locked a determined intruder can quickly break normal window glass to enter a building or a classroom. This plan proposes a bullet/break resistant coating of all windows in the entries and the first floor classrooms. An intruder might attempt to break the windows, but they would resist breakage and penetration delaying an unauthorized intruder.
