 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Baldwinsville Central Schools have been working to improve the security of the buildings in the district. They believe that students who feel secure in their environment will be able to focus better and acheive more. The district has been approaching this from a number of different directions.

The first component of this application is video security. The district has a strong video security system in place, but has identified a number of vulnerable areas in multiple buildings. This plan proposes to place additional video cameras in those locations. By maintaining good vigilence, the district can identify incidents as they are happening and respond quickly. They can also provide important information if an emergency event should occur. Finally, after hours, unauthorized visitors in the building can be quickly identified and appropriate responses can be made.

The second component in this plan is an upgrade on the window security. Windows are a praticular vulnerability in schools. In earlier projects the district has applied window coatings to reduce that vulnerability. Foyers and a glass hall have had bullet resistant coatings applied that prevents them from being breakable and a possible access point for unauthorized entry. Baldwinsville is proposing to apply these coatings to other windows in the district. For example. Classroom doors all have a windows in them. The teachers could lock the doors to shelter their students. With the glass in the doors an intruder could quickly bypass the locks and gain entrance to a classroom or office. The ballistic coating for the glass makes the door much more intruder proof.
