 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

The amendment was needed to clarify our pre-bid design estimates with actual bid and construction installation costs. It was mostly to confirm quantities and unit costs, as well as the removal of some items. The items being removed were exterior cameras; PA high mounts; new door entry hardware, entry control card readers, and access control interface to PA.

Additional Response requested:

When we did the original SSIP, ECC Technologies had a preliminary design and estimate where we had \$482,241 estimated for Installation and Integration services for the Video Surveillance & Management System (VMS).

When Fergusson Electric won the Bid, their contract schedule of values had the Installation and integration VMS Services costs spread across the schedule of values items 1,2,3 & 4 for a total of \$2,088,000. I had Fergusson breakdown the values (see attached spreadsheet), where they said they carried \$321,000. We did have fewer cameras and servers, so the install/integration costs would be expected to go down as well.

From time the time of preliminary design, we went through the capital project design and bid, and fortunately bid numbers came in competitive. If you recall the other three bidders were significantly higher, where the opposite could have been true. This is not uncommon for capital project design vs. bid cost comparisons.

We will be using any price/quantity decreases and/or savings in a future project.
