Our district uses three separate ISPs (Verizon, Optimum, and Lightspeed via BOCES). Verizon provides us with 1GB service, Lightpath with 2GB, and BOCES is 150 Mb. I estimate that we provide 645 Mb of bandwidth per 1000 students, which exceeds the SSIP requirements.

As indicated above, our wifi network is extremely robust. We have a 2 GB connection, three ISPs, load balancing, and the ability to shift from one ISP to another should one experience downtime or an outage. Our goal was to provide 500 Mb per 1000 students, a metric we have exceeded. This was based on the SSIP's requirement of a little over 300 Mbps for our student population. Our goal is always to exceed expectations rather than just meet them, and we want to future proof the district given the preponderance of internet-enabled devices in the district, including 3000 Chromebooks, 200+ Smart Boards, student devices, and more.

Since we are purchasing one-to-one Chromebooks to refresh our existing fleet, we already have everything in place to use these devices. We have been fully one-to-one since the beginning of the COVID-19 pandemic, and our students have been utilizing these devices in classrooms for two full school years. We provide a WAP for every instructional space in the district including a number of outdoor spaces and have had no extended downtime (> 5 minutes) in four years. We have charging carts available in every elementary school classroom and charging stations placed strategically throughout or middle and high schools. In short, this is the continuation of a successful existing program, so compatibility and infrastructure concerns were addressed years ago.

One-to-one devices are perhaps the biggest step forward for true differentiated instruction in education history. We are a fully one-to-one district, and we have purchased online subscriptions and programs specific to certain student populations (i.e. autism and developmentally delayed) in language development, math, reading and social/ emotional learning, among other areas. One-to-one devices alow students to utilize these programs to learn at their own pace. Additionally, software like IXL Learning allows all students to progress down personalized learning pathways that are responsive to their inputs and customize the student's future learning. In addition to providing one-to-one devices, we also offer mobile hotspots to any family who requests one, which means we've effectively extended the classroom into every home, and ensured that Internet and device access are equitable and available to our entire student population. Students have taken district-provided Chromebooks on class trips, to national competitions, have used them during debate prep, and teachers frequently do the same. These replacement Chromebooks will allow us to continue serving our student and teacher population in this way, and as such their procurement is vital to the continued functioning of our district.

One-to-one computing programs also provide significant benefits to students with disabilities and ELL students. We offer a Chromebook or an iPad (and in some cases both, depending on our students with disabilities' needs) to use for academics and leisure as part of a behavioral intervention plan. We have acquired specialized devices and accessories including wheelchair mounts, devices with eye tracking for input that allow students with disabilities to just be physically possible to interact with devices, and the aforementioned apps and subscriptions. Personalization and individualization are critical to Jericho's educational programs, but there is a particular emphasis on them as it pertains to special education. Specific apps like Proloquo2Go, Read Aloud, Read&Write, and dozens more are deployed for students based on their needs and their teacher's instructional approach. Technology is interwoven through everything we do at Jericho, and this extends to all general and special education classes. ELL students are similarly supported by suites of apps that offer differentiated instruction based on student abilities.

One-to-one devices at Jericho are usually taken home by students, which means families without internet-enabled devices at home now have a way to access the Internet, communicate with the district, and participate in digital life. ParentSquare will be in use by end of the school year, and parents will then be able to use student Chromebooks to access this resource, among many others. Every student having a device obviously aids in distance learning, and the district is proud of its work during the pandemic, which illustrates that our program has been running successfully for several years.

The response to this is ultimately very similar to the response on the ITP. We provide a diverse array of training methodologies, beginning with in-district trainings including virtual Q&As, provide Remote Desktop assistance, and supplement trainings with hands on interactions. These are generally conducted by the Director of Technology and technology staff members. We have leveraged targeted professional learning to improve our staff members' tech savvy and comfort with apps and services like Zoom, Canvas, Google Classroom, Google Drive and related apps, creating hyperdocs, Smart Boards, Smart Learning Suite (now Lumio), Office 365, Kami, Nearpod, and Peardeck. All of those products are utilized on our district's Chromebooks, so providing teachers and other staff with targeted training helps make them experts on these platforms and improves the efficacy of our one-to-one program. Targeted PD involves bringing outside vendors into the district, but we also utilize Nassau BOCES' Model Schools program for teacher training and support. Additionally, other staff members receive training from BOCES on topics including Excel and Google tools.

Given that our instructional program is built on the foundation of a successful one-to-one program, we've chosen to provide device-centric support to parents and teachers, too. We use the OTIS platform through Teq, which offers hundreds of training modules available free of charge to parents and every member of Jericho's staff. These modules include a pathway for Chromebook training that illustrates to parents and staff how these devices work, best practices in use, and even walkthroughs of specific Google applications. Finally, we utilize Superintendent's Conference Days for quality professional learning. During these sessions, teachers are provided Chromebooks to worn on to further familiarize our teaching staff with using Chromebooks for teaching and learning.
