 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Security continues to be a prime concern with students, parents, teachers and administrative staff throughout the District. The District is always looking for ways to improve the security in each of the school buildings. This investment plan will allow the District to add and upgrade critical security features in all of our buildings to maintain and improve the safety and security of all of our students, staff and parents.

New Servers - Security camera technology has been added over the years and is now over working the servers used to process and store the data from the cameras. Frame rates during video replays have slowed down and it is easy to miss something on the video. The history of how long recordings are maintained has been shortened and, on occasion, the recordings are stopped because the server is full and needs to be serviced by a technician. The District will purchase 3 new servers to replace existing servers which have outlived their useful lives due to the number of cameras that are now being utilized throughout the District. These servers will enhance the review of security footage as well as increase the length of time that videotape review will be available.

Replacement of outdated cameras - The replacement of outdated security cameras will maximize safety and security for students and staff in all buildings by providing coverage for both the interior and exterior spaces.

<u>Access controller for elementary school entrance</u> – Access controllers provide additional security for all district buildings. However, there is a need for an access controller at the auditorium entrance at one of the district's elementary schools.

<u>Video Intercoms</u> —Currently, the District uses coordinated video intercoms in all school buildings which provide a reliable way to focus on the face of the visitor to authenticate their identity. They provide security in each building the ability to see and converse with each visitor before allowing them into the building. This added means of security allows staff a better opportunity to evaluate visitors to the building for security concerns prior to their entry into the building. The District would like to enhance the use of these video intercoms at all frequently used entrances.

<u>Wireless network upgrade</u> – The district needs to improve the wireless network capabilities in the large rooms (gyms, cafeterias and the like) in the middle and high schools. This will prepare the district for the online testing that New York State is moving towards.
