Stockbridge Valley C. S. currently has sufficient infrastructure that meets the Federal Communications Commission's 100 Mbps per 1,000 students, and contracts with the Mohawk Regional Information Center (RIC) at the Madison-Oneida BOCES in Verona, NY, to provide and maintain Network operations for the district. In February 2022, the Mohawk RIC contracted with Archi-Technology, Technology Consultants, to conduct a district-wide comprehensive Technology Conditions Survey intended to provide the district with an objective evaluation of the current state of the district's technology, and provide recommended improvements/upgrades to bring the district's technology infrastructure and IP-based systems up to current industry standards to meet future needs, and needs during high demand periods, at times of implementing computer-based testing (CBT). As a result of this survey, improvements and upgrades to the district's infrastructure were recommended particularly to maintain the Network Switches, Wireless Access Points (WAP's), and Licensing.

Per a Technology Condition Survey Report conducted in February 2022, by Archi-Technology, Technology Consultants, the Stockbridge Valley C. S. plans to use Smart Schools Bond Act funds to provide for recommended upgrades and improvements needed to bring the district's technology infrastructure and IP- based building systems up to current industry standards. Particularly, recommendations were made to upgrade the Network Switches, Wireless Access Points (WAP's), Required Licenses, Cable, and Uninterruptible Power Supply (UPS) to maintain wireless connectivity throughout the school building for the next several years.

The 2022-2025 Stockbridge Valley C. S. Instructional Technology Plan identified a goal to "expand and upgrade the network capacity in order to support ongoing and future instructional and operational initiatives." This Smartbond Investment Plan would include supporting network and wireless access point upgrades to meet the consistency and connectivity needed on a daily basis, as well as provide for the reliability for computer based testing (CBT) in the future. Stockbridge Valley C. S. provides ALL students with access to technology through 1:1 Chromebook or IPad devices, and All instructional staff with laptop computers as part of the comprehensive instructional program to deliver and support rigorous academic standards and work toward student growth and improvement in academic performance. Providing students and staff with 1:1 devices and maintaining an ongoing replacement plan for these devices is part of the district's regular program. Stockbridge Valley C. S. contracts with the Mohawk Regional Information Center (MORIC) at the Madison-Oneida BOCES to support a robust network and wireless devices for student and staff access to the internet from 1:1 devices. In the spring of 2022, the district met with MORIC leaders as part of an annual meeting to review the district's Local Area Network and discuss goals for continued upgrades to the district's technology infrastructure. At this meeting, reports were provided indicating that several of the district's current existing wireless access points and network switches had reached an "end-of-support-date" and needed to be upgraded to maintain the network, plan for future demand, and provide the continuity of access to meet daily instructional and operational needs of the district. Specifically, twenty-five (25) switches and sixty (60) existing Access Points were at or nearing end-of-life and needed to be upgraded. The proposed Smart Bond expenditure would allow for these upgrades to meet the continuity and reliability needed using current and existing raceways within the building.
