 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Deruyter Central School has developed a plan to improve the safety and security of their facilities. They believe that a safe school helps students to be confident and successful.

The first initiative has two components which will combine to upgrade the security at the entrances to the school. The doors of the school were designed when the school was the center of the community. The doors were open portals for the community to support student learning. Today the schools need to monitor individuals coming and going. The challenge for school leaders is to secure the main entrance while still facilitating the entrance of the authorized visitors. Both of the entrances were constructed with extensive glass windows. These need to be secured. Deruyter proposes that ballistic resistant coatings be applied to the glass. The windows will be secured from people using brute force to enter. Additionally, the district proposes to upgrade the reception area of the main entrance. There is a temporary office for the receptionist, but it is not secure. The window is made of plastic and the door area is not secure. The district is proposing to secure the reception area by constructing a permanent office for the receptionist. The district will remove the temporary door, The district will also install a "bank teller window." This window and the reconstructed office will provide the receptionist with a safe location for receiving visitors to the building. The visitor will be authorized to enter the exterior door to the building. In the secure vestibule the visitor can provide identification to the receptionist via the secure window. Only when the correct identification and authorization is provided will the visitor to proceed into the building.

A second initiative to the plan are the doors to classrooms. Many of these door locks only have bolts operated by a key from the exterior. In the event of an intruder in the building the teacher will need to stand in the hall and lock the door before the classroom is secure. By replacing these cores, the classroom can be secure at the touch of a button. A much better practice.

The final initiative is emergency notification for the district. The district is proposing two parts to this improvement. They want to install digital displays in key locations in the building. These displays will share important information when there is a crisis. These units, along with exterior blue strobe lights will keep the students informed of the nature of the emergency. It will also inform parents or visitors of the correct

next steps. Blue lights will tell the parents approaching the campus that there is an incident in the building or on the campus and NOT to enter or approach.

All plans and specifications for the erection, repair, enlargement or remodeling of school buildings in any public school district in the State must be reviewed and approved by the Commissioner. Smart Schools plans with any expenditures in the High-Tech Security category require a project number from the Office of Facilities Planning. Districts must submit an SSBA LOI and receive project numbers prior to submitting the SSIP. As indicated on the LOI, some projects may be eligible for a streamlined review and will not require a building permit. Please indicate on a separate row each project number given to you by the Office of Facilities Planning.
