The Charlotte Valley School District has worked closely with Hunt Engineers & Architects to complete a building survey for the State Education Department. Hunt surveyed our buildings and met with the administration and technology teams to understand our goals. Hunt supplied us with a detailed set of plans that will build on existing wireless coverage in our classrooms, large group instruction areas and common areas, such as our cafeterias and auditoriums, to create a more robust wireless network. The district's current wireless network has good coverage of the instructional spaces throughout the building. The SSBA funds will be used to upgrade cabling servicing wireless access points to the existing wireless devices.
