Purchase and install of IP Public address system to work, current system is too old and cannot be repaired. The devices can give notifications with written messages and verbal messages. They are also capable of being used as intercoms for announcements. Intended to use original PA system, but it needs to be updated to work properly as a mass notification system.

The District's initial allocation was \$1,253,633. The District's original plan was submitted for \$1,200,000. The District's submitted expenditures to date have totalled \$1,080,849.82, due to cost savings of \$119,150.18 from the original plan. The breakdown of cost savings from the original plan are shown in #5 below. In addition, the \$53,633 of funds not allocated in the original plan are being added. This results in the total requested expenses to be approved for this amendment of \$172,783.18 (includes net increase of \$53,633 & prior savings of \$119.150.18).
