The goal of this project is to utilize the SMART Schools bond to meet or exceed this standard in the new addition to Council Rock Primary School built to accommodate full-day kindergarten and the expansion of the K-2 primary school.

The District will be constructing 12 general education classrooms, 2 special education classrooms, and will be expanding the cafeteria into a cafetorium into to transition from a half-day kindergarten program into a full day kindergarten program. Utilizing the SMART School Bond will allow the District to duplicate the district's current connectively and internet access standards. This will include the installation of network access infrastructure including, LAN fiber backbone, LAN distribution switch and 24 new switches. In addition, within the newly constructed wing, there will be 244 LAN data drops installed.

Amendment #1 - 11/29/2022: The construction of the new classrooms and related cabling required the professional services of a licensed electrician. The District has modified its SSBA to allocate a portion of the cost of cabling to the Smart Schools Project. Given the complexity of the project, these costs were initially earmarked to be claimed for Building Aid in the final cost report

Conversely, the cost of the LAN fiber backbone was installed and implemented as described in the original project plan; however, given the complexity of the project, the District was not able to itemize exact costs of the backbone when claiming for reimbursement from SSBA and therefore will claim these expenses for Building Aid.

The District is proposing to use SMART School funds to construct and outfit a new secure entranceway and vestibule for the Council Rock Primary School. Currently the District maintains a single point of entrance to the building, however, once allowed into the building a visitor has unvetted access to corridors and classroom space. The proposed design of the new construction would allow for visitors to be buzzed in by security or main office staff, screened further in the holding vestibule, and then allowed entry into the main office for check-in. The purchase will include general construction, including door hardening. In addition, the District will be utilizing high tech security equipment and systems to provide secure entrance to new wing being constructed to accommodate full day kindergarten.

As part of phase II Amended Project Narrative, the District is partnering with Rel-Comm to implement multi-activation announcements so that security, administrators and maintenance can access communication systems from SIP phones, main office, two-way radios and mobile applications. For communication enhancements, the District looks to install SIP, IP and analog speakers for interior and exterior applications with the goal of embedding graphical one-touch activation for live voice, recording, text to speech, and Wav file announcements.

A third objective is to expand the number and functionality of "lock down buttons." The District is looking to expand functionality by have
