The Brocton Central School Security Camera System is an essential component for safety, as a deterrent, real time monitoring of the campus, and investigative purposes.

Our current system is approximately 8 years old and in need of replacement. The proposed new system would include a high end dedicated server and 30 new security cameras. The new system will work with older cameras which will allow the district to replace cameras as needed

without replacing the whole system. With the this flexibility it will add to the longevity of the system as new camera hardware and features become available in the future.

The project will add 13 new exterior and 17 internal cameras. These cameras will add needed coverage of areas of the campus that are currently not visible. It will also increase the resolution and quality of the recordings, include better search features, and give us the flexibility to add more cameras while maintaining our 30 day recording requirement.
