New devices will foster increased collaboration through the use of audio pods for group work. Portable interactive panels provide the ability to move the panels closer to students with limited mobility as well raise and lower the panels to afford all students the ability to interact with the screen. Multiple touch capability will allow more than one student to interact with the panel simultaneously. Document cameras in conjuction with the interactive panels allow for increased visual interaction with content which is needed to reduce current learning gaps and afford students the opportunity to directly model learning for the class. Document cameras can also be used as web cameras which will allow classes to participate in virtual learning opportunites outside of their physical classroom.
