The Hoosick Falls Central School District received alternative funding for most of the servers, switches, and power supplies needed for the new network. Those items already purchased were removed from the investment plan. The District determined that five more switches and 11 more wireless access points were needed for the new network and the updated cost were included in the plan. The patch panels were purchased through the capital project and were removed from the investment plan. The costs and materials needed for the rooftop antennae and coaxial cabling for emergency responders to maintain adequate signals for communication was evaluated and changed by the vendor. The updated costs and materials were adjusted in the investment plan.
