Ithaca City School District intends to use Smart Schools Bond Act funds to install high-tech security features (Category 4 above) in school buildings

and on school campuses. The ICSD security plan provides for upgrades and replacements under the Smart Schools NY Allocation that will be

implemented upon approval from New York State Education Department. The Ithaca City School District plans to enhance the minimal security

systems at each building with: A) Access Control Systems and B) Electronic Security Systems, as described below.

A) Access Control Systems: This system replaces the typical mechanical key controlled door lock with a door locking system that uses an access

card or fob as the access credential. This provides potential added features including:

- 1. Student/staff issued access card or fob functioning as the building access method
- 2. Tailored access privileges for each user.
- 3. User access privileges can be deleted or modified without retrieving the issued access card.
- 4. Automatic card deactivation when a student, visitor or employee role becomes inactive.
- 5. Individual building /departments control their facility access controlled doors via centralize software interface.
- 6. Cancelation of all access privileges in case of lost or stolen access card.
- 7. Monitor and document building access activities.
- 8. Locking or unlocking doors performed by automatic schedule or manually via software.
- 9. One access card or fob programed for first responders.
- B) Electronic Security Systems: This system consist of Cisco network attached security cameras for buildings with no current system or replacement

where antiquated systems are deployed, but cannot be upgraded. This provides potential features including:

- 1. Security cameras with digital zoom and tamper proof dome
- 2. Network attached cameras allow ease of access for school administrators within a building and across the district regardless of location
- 3. Centralized storage for critical incident playback
- 4. Access to live activity can be provided to police and fire departments
