The interactive display boards will help to differentiate instruction by allowing teachers to present interactive experiences for students through visual, sensory, and audio learning. This will also present the option to connect directly with student 1:1 devices, and to explore supplemental resources for curriculum. Our student learning will be expanded inside and outside of the classroom as a result of increased options for curriculum resources, virtual field trips, options for connecting with teachers and learners through video-conference, and having enhanced classroom technology available. In regard to benefits for students with learning disabilities and English language learners, improved technology will enhance the audio, visual, and overall sensory experience for learning options. Students and teachers can interact with the classroom technology through applications, tools, and curriculum resources. The overall addition of the interactive display boards allows for supporting reduction in learning gaps because the technology being consistent across the district allows for students to learn how to utilize the technology from grade level to grade level and across content areas. This is especially helpful in that our teachers will have consistent, reliable, and uniform technology which allows for in-district professional development opportunities and content area and grade level specific resource sharing to help with vertical and horizontal curriculum mapping and best practices.
