Norwich had proposed using Smart School funds and Federal Erate funds to upgrade their network infrastructure to support next generation traffic. Norwich proposed upgrading their switching modules to allow maximum through put and POE capacity throughout the network infrastructure. The district also proposed replacing many of the active cable drops with new Cat 6A cable drops supporting POE network devices and additional wireless capacity.

These projects were all completed using Federal Erate funds and Capital project funds. The Smart Schools dollars remaining are not required. The district proposes moving these funds to High Tech Security to complete that project.

The new boards require less electricity and do not impact any other HVAC or infrastructure. While this project came in under budget, Norwich is still going to increase the hands on opportunities in the Science Technology Engineering and Mathematics. (STEM) This includes robotics, coding experiences, and circuit design. None of these will impact the district's infrastructure.

High-Tech Security Features

 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

TNorwich City School District feels that the safety and security is their Number 1 priority while they are educating their students. Every student is more successful when they feel safe and secure in their learning environment and this Smart School Spending Plan. The Safety and Security plan has many components. This application addresses two of those.

The first component in this application is for video security. Norwich has a video security system currently. Unfortunately, it has limitations. Many of the cameras are low resolution analog cameras with limited fields of vision. It is frustrating to the administration because the limited coverage means that events are occasionally missed. It is doubly frustrating that some of the events that are actually recorded are difficult to view. Norwich building leaders have identified several vulnerable locations where video security will help them manage any incidents. High resolution digital cameras will improve the ability to view the events including exterior and night events. The system will also have an upgraded video server installed that will allow the district to extend the storage of all video and archive video of incidents for future review.

A second component of this security upgrade is controlling the doors in classrooms. Traditionally, schools have tried to maintain an open, inviting environment encouraging students to come into the classrooms. Many teachers have chosen to slide a block under a door to hold it open which creates a problem in the event of a fire or in the event an intruder attempts to enter the school buildings and make contact with students and teachers. Norwich is proposing the installation of devices that will hold the doors open if the teacher chooses, but close automatically close in the event of an emergency. These will operate similarly to the corridor fire doors. In the event of an emergency pressing a single button or activating the fire alarm system will close all classroom doors.

Finally, the district is proposing adding to their existing classroom notification system. They are proposing adding digital devices in public areas that include strobe lights, digital signage and audio speakers. The current emergency notification system is audio only. The new system will have the traditional audio speakers for audio announcements. In addition, it will have digital signage. During normal operation these signs appear to be digital clocks. In the event of an emergency, digital messages such as "Unauthorized individual in the building. Please shelter in place" or "Norwich Schools will close at 1 PM today due to inclement weather. All after school activities are cancelled" can be displayed. Finally, there are three, colored strobe lights. These lights can draw attention to the device in an emergency or even flash specific colors for specific emergencies. Perhaps red in the event of a fire or smoke and perhaps blue in the event of a shelter in place.

Planning and coordinating a system of this complexity is very very difficult. When you add a scenario that this system will span four instructional buildings as well as two support locations the detail hits new levels. This amendment proposes to provide the additional funds to help the district implement, program and transition from the mulitude of old systems to the new comprehensive system. Included in this is the detailed system implementation. Taking the hundreds of un-boxed products and forming them into a single, reliable system. Additionally, it provides for the on-site project manager to coordinate between facilities staff, installation contractors, and end users in each of the buildings. Finally, these funds will be used to trouble shoot the system and make sure that it functions the way it was designed before turning it over to the district and closing out the project.
