The FCC requires 100 Mbps per 1,000 students - South Orangetown would need a minimum of 300 Mbps. Currently our connectivity is 2,000 Mbps with the ability to scale up to 10,000 Mbps. In addition, our connectivity is redundant, the district employs to separate connections to the Internet.
