 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Spencer-Van Etten Schools has been approved for an upgrade to their high tech security plan. During the two years since the original application the district has identified some additional scope that is required. The district would like to complete a capital intensive security renovation to the doors at the middle and high schools. The main entrances of these buildings will be converted to secure, double door vestibules. Currently, these buildings are serviced by single door main entrances. The administration has very limited control of people entering the building. The visitor is "asked" to start their visit in the building office to sign in and get to the appropriate areas. In reality, once a visitor is allowed to enter the building, it is possible for them to travel, unimpeded to all areas of the buildings. The district is planning to build a second set of doors creating a secured vestibule. The visitor will be allowed to enter the first door, but cannot proceed into the building by the locked second set of doors. They will be asked to provide identification at a security window before the second set of doors are unlocked and they can proceed to their desired destination. The district would like to create a safety door at the elementary.

In the Supplemental Application Approved Door Hardenting work was approved to be complete as a component to this work. The Approved Door Hardening was bid and completed by the contractor responsible for the Capital Intensive Security Project and invoiced as such. The invoice did NOT break the Approved Door Hardening our as separate work. This amendment is to re-allocate the funds to the Capital Intensive catagory and allow the district to claim those funds.
