DescriptionRegentsItem:	Requests an amendment to its charter to: 1) Change maximum enrollment from 1,675 to 2,365 (The request is to add 264 students in fall 2014 and does not anticipate being at maximum enrollment until the 2019-2020 school year) and 2) Add a school building that is in close proximity to the main campus. This additional building will be within Buffalo city lines and therefore it will be outside the district of location.

The application for this school is being reviewed for possible action at an upcoming Board of Regents meeting.

Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <http://www.p12.nysed.gov/psc/law.html>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing revision. This hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.

Please provide the following required documentation:

- A copy of the public hearing notice must be provided to the Charter School Office at the time of dissemination
- Written confirmation that this hearing was held must be sent to the Charter School Office no later than the next business day following the hearing.
- Copies of any and all written records or comments generated from this hearing must be sent to the Charter School Office within 15 business days after the hearing.

The documentation listed above should be submitted electronically to charterschools@mail.nysed.gov (the subject line of the email should include Public Hearing).

In addition, the Board of Regents welcomes your comments on the proposed charter school revision, including those related to the programmatic and fiscal impact of the proposed revision or other public and non-public schools in the area. Comments should be submitted to charterschools@mail.nysed.gov or the physical mailing address in the letterhead of this memo.
