This notice is to inform you that the New York State Board of Regents received the following proposed charter revisions from the Harlem Success Academy Charter School. Details of this request are provided in the enclosed chart. In addition, the charter revision request letter submitted by the Chief Executive Officer of the Success Academy Charter Schools and which describes the revision request is also attached for your information.

Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <http://www.p12.nysed.gov/psc/publichearing.html>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing application. These hearings, which are required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.

1. A copy of the public hearing notice must be provided to the NYSED Charter School Office at the time of dissemination.
2. No later than the next business day following the hearing, written confirmation that this hearing was held must be sent to the NYSED Charter School Office.
3. Copies of any and all written records or comments generated from this hearing must be sent to the NYSED Charter School Office within 15 business days after the hearing.

In addition, the New York City School District has the right to comment to the Board of Regents on this proposed charter revision. Such comments should be
