Jasper Troupsburg CSD has an approved application to upgrade the network infrastructure for their district. Unfortunately, less than 30 days after the application was approved, the secondary building was flooded. A total wipe out. The district is currently in the process of working with FEMA to plan and reconstruct the secondary building.

Jasper Troupsburg is requesting that the scope of work in the original plan be reduced by \$175,000. This is the amount of the work that is no longer needed at the secondary building. The original Smart School Committee had identified High Tech Security as their next priority. The district intends to use the funds from the reduction and move those funds to High Tech Security at the Elementary Building.

Jasper Troupsburg is interested in making improvements for the safety and security of their students. This amendment reflects work to be done to insure the safety and security of the students at Jasper Troupsburg Elementary School. The building was designed when schools were community resources and centers. The doors were open and members of the community could come and go. Unfortunately that has changed. Today the access to the school should be convenient for people who belong there. In addition, the district needs to know who is in the building and who they are expecting to meet with. Parents that are arriving to pick up their students need to have access to their children in a controlled manner.

Jasper Troupsburg wishes to construct a double door vestibule at the entrance to the elementary building. This entrance will allow individuals to enter the first set of doors. Once inside they will be greeted by a staff member who is stationed behind a bank teller style window. The visitors will not be allowed to proceed any further into the building until they are identified, their destination specified, and an escort provided if necessary. Only after this is accomplished will the second set of doors be unlocked and the visitor allowed to move forward to their destination. In this manner the students can work in a safe, secure environment and the visitors can access the school as appropriate.
